REQUEST FOR EXPRESSION OF INTEREST FOR CONSULTING SERVICES

1. Department of Water Supply and Sewerage intends to engage consulting firm (the Consultant) for Feasibility study of integrated water supply & waste water management projects in Ten municipalities which are grouped into Three Packages. First notice of request for expression of interest was published on 2073/11/11 in the Rising Nepal daily News paper. Since the required number of consulting firms could not be short listed for Package Number Three i.e. Birendranagar (surkhet), chandannath(jumla) and Dipayal silgadhi (Doti) .Department of Water Supply and Sewerage re-invites for expression of interest from consulting firms for the Feasibility study of integrated water supply & waste water management projects in three municipalities mentioned above.
2. Department of Water Supply and Sewerage (DWSS), under the Ministry of Water Supply and Sanitation, is the lead agency for the Water Supply and sanitation sector in Nepal.
3. Expression of Interest (EOI) is requested from the interested eligible Consulting Firms or Joint Venture (JV) Firms that have adequate experience in Feasibility study of integrated water supply & waste water management project.
4. The consulting services will require about 16 expert person-months , implemented over 3 calendar months from the commencement date. MOWSS is the Executing Agency and the Project will be implemented by DWSS/SDMS. The Consultant shall report directly to the chief of the SDM section of DWSS.
5. This project is funded by the Government of Nepal. Payment to the Consultant shall be made in Nepalese Rupees (NRs).
6. EOI must be submitted at the address indicated below on or before 17:00 hours local time on the 16th day from the date of first publication of the EOI notice. If the last date of submission happens to be a public holiday, submission shall be made on the next working day. Submissions shall be made in closed envelope and the title "*Expression of Interest (EOI) for Consulting Services: Preparation of Feasibility study Report of integrated water supply and waste water management project*". shall be written clearly on the envelope.
7. DWSS reserves the right to accept or reject any or all proposals, or to cancel the entire proceedings without giving any reasons whatsoever.
8. All submittal from the Consulting Firms shall be in English language.
9. The EOI forms will be available at sewerage Development and Management section (SDMS),panipokhari,Kathmandu.
10. Tax Clearance Certificate/ Approved Copy of income detail Submission/ Evidence of time extention given by Concerned authority to Submit income detail is compulsory for eligibility.
