1. KVDA invites Expression of Interest (EOI) for the purpose of short listings of the eligible, qualified and experienced national and international Consultancy Firm / Company to submit proposal for

EOI Documents delivered after the due date and time shall not be entertained. EOI Documents will be opened physically at 14.00 PM local time on 16th day of publication of this notice for national bid and 31st day for international bid in the office of Kathmandu Valley Development Authority, Anamnagar, Kathmandu. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day.
4. Short-listings will be conducted following the criteria contained in EOI Documents and shall be informed to all applicants. Only those short listed maximum six Firms(s)/Company (s) shall be invited to submit the Request for Proposal (RFP) for the mentioned job at a later stage in a merit basis. One Firm/Company is permitted to submit only one EOI either single or in a joint venture. If two or more firms/ Companies are to be provided services as a group, organizations or a joint venture, the name, address, profile of such firms and the name of lead firm should be provided. The consultants can form a JV but there shall be maximum of 3 partners only.
