2. Nepal Oil Corporation Ltd invites sealed bids from registered suppliers as per Income Tax Act for the procurement of the following Aircraft Refuellers.

3. The Procurement Committee, "the Purchaser" invites sealed bids from the interested bidders for the procurement of Contract stated above under **International Competitive Bidding**.
4. To participate in this bidding, the bidders must have been currently operational in the manufacturing industry / fabrication of Aircraft Fuel Bowser for at least 5 consecutive years and Over the past five (5) years as of the date of bid opening must have completed at least five (5) successful contracts of supply and delivery of aircraft refuellers of 12 KL capacity or more.
5. Interested Bidders may obtain further information and inspect the bidding documents at the office stated below or can download the document from www.bolpatra.gov.np.
6. Bidding document may be purchased on or before **15:00 hrs of 19th March 2017** from the offices stated in the Bidding Document by the interested Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Nepali Rupees **20,000.00 (Twenty Thousands only) or US\$ 200.00 (Two Hundred Only)** in cash or in any form stated in the Bidding Document. Any bidder wishing to submit downloaded document shall submit a bank deposit voucher (original) of the above fee. In the absence of the bank deposit voucher, the bid shall be considered nonresponsive.
7. Bank Guarantee issued by any finance company in any form will not be accepted.
8. Bidders have option to submit the Bids electronically as stated in the Bidding Documents. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's website www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. In the absence of the bank deposit voucher, the bid shall be considered nonresponsive.

10. A Pre-bid meeting which Potential bidders may attend will be held at NOC, Babarmahal at 14:00 Hrs Nepal std. time on Date: 28th February, 2017.
11. Sealed Bids must be submitted to offices stated in the Bidding Document on or **before 12:00 hrs of 20th March, 2017**. Documents received after this deadline shall not be accepted.
12. Bids shall be opened in the presence of Bidders' representatives who choose to attend **14:00 hrs of 20th March, 2017** at the office stated in the Bidding Document.
13. Bids must be valid for a period of **120 days** counting from the day of bid opening and must be accompanied by **bid security, amounting to a NRs 7.8 Million** or a freely convertible currency **in the form of a bank guarantee** issued directly by a reputable bank and counter guaranteed by an "A" Class local bank accredited by Nepal Rastra Bank, in the form provided in the bidding documents. The Bid security shall be **valid for minimum 30 days** beyond the bid validity period.
14. If the specified date for pre-bid meeting, last date of bid **purchasing and submission/opening date falls on a Government holiday** then the same time of next working day shall be considered for such events. However, the date for bid submission and opening shall be **considered the next working day of last date of bid purchasing. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.**
15. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
16. The Purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
