Invitation for Bids

IFB No: DOHS/G/ICB-140/Procurement of Inj. ARV and Inj. ASVS

First Date of Publication : **26 January, 2017**

1. The Ministry of Health, Department of Health Services (DoHS), Logistic Management Division (LMD), Teku, Kathmandu now invites sealed bids from eligible and qualified bidders for the Procurement of **Anti Rabies Vaccine and Inj. Ante Snake Venom Serum** to be delivered at the Central Medical/Vaccine Store, Teku, Kathmandu.
2. A bidder may bid for one or more slices. Bidders bidding for more than one slice will so indicate in their bid form, together with a statement regarding discount/cross discount if any. Bidders shall quote for the complete quantity of quoted slice(s). Evaluation will be conducted for each slice, with the final award being determined based on the combination that is of least cost to the Purchaser.
3. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the Public Procurement Act of Nepal and is open to all bidders from Eligible Source Countries as defined in the bidding document.
4. Interested eligible bidders may obtain further information and inspect the Bidding Documents from the Logistics Management Division (LMD), Teku, Kathmandu on GoN official working days on office hours from **26 January 2017 to 13 March 2017** at their own convenience, or, on the LMD website (www.dohslmd.gov.np) and PPMO website (www.bolpatra.gov.np). Interested bidders must first register on the PPMO website to access the document and choose the electronic bidding procedure.
5. A complete set of Bidding Documents in English may be downloaded from the PPMO website or LMD website or be purchased from **26 January 2017 to 13 March 2017** by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of **NPR 10,000.00** or equivalent convertible currency. The method of payment will be in the form of cash deposit certificate in **Revenue Title no 14227, Office code no. 27-370-11, Account No.1-1-001 of Rastriya Banijya Bank, Teku Branch**. Foreign Bidders may also pay through a bank draft in favour of the Logistic Management Division (LMD), or may receive the (numbered) Bidding Documents from the LMD against submission of Cash Payment voucher at above mentioned bank account.
If requested in writing and on payment of an additional non-refundable fee of **NPR 6,000.00** or equivalent convertible currency per set, documents shall be sent through a reliable courier service. The LMD, however, will not be responsible for any delay or non-delivery of the documents so sent.
6. For the purpose who choose to submit their bid electronically through e-procurement section of PPMO website: <http://www.bolpatra.gov.np>, the bidders may either purchase the hard copy of bidding documents or may choose to download the necessary part of bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. In case of bidder who choose to download and submit bid electronically, the bidder shall be required to deposit the cost of bidding document as specified above in the above mentioned Account No. of LMD at Rastriya Banijya Bank, Teku Branch and electronic scanned copy (pdf format) of the Bank deposit voucher/tele transfer receipt shall also be submitted along with the electronic bid files.
7. Sealed Bids must be delivered to the address below at or before **12:00 hours (Nepal Time) on 14 March, 2017**. Alternatively, bidders may submit their bid electronically through e-procurement section in PPMO website: <http://www.bolpatra.gov.np>, before the above deadline and as specified in the Instructions to Bidders. Documents received after this deadline shall not be accepted.
8. Bids must be valid for 120 days after the date of bid opening and must be accompanied by Bid Security not less than the amounts mentioned on the table or the equivalent freely convertible foreign currency. The Bid Security shall be in the name of the Bidder and in the case of a Bid Security issued by a foreign bank, the same shall be counter-guaranteed by a Class "A" Commercial Bank in Nepal. The Bid Security must be valid for thirty (30) days beyond the bid validity period (i.e. **valid upto 11 August, 2017**). Bids will be opened in the presence of the bidders' representatives, who choose to attend in person, at the address below at 13:00 hours (Nepal Time) on **14 March, 2017**.
9. If the specified date for submission and opening of the bid falls on a government holiday, then the same time of the next working day shall be considered for such events. The bid validity and validity of the bid security remain unchanged unless amended by another notice.
10. In the case of discrepancies or error in bid documents, bid notice or any other document, the DOHS reserves the right to amend and correct at any time
11. DOHS reserves the right to accept or reject wholly or partly or all bids without assigning any reason whatsoever
